TO AUTHORIZE (1) THE TRANSPORTATION OF ALCOHOLIC BEVERAGES FROM THE LICENSED PREMISES OF A NEW JERSEY LICENSED MANUFACTURER OR WHOLESALER OR FROM A LICENSED PUBLIC WAREHOUSE DIRECTLY TO POINTS OUTSIDE NEW JERSEY, (2) TRANSPORTATION OF BEVERAGES BETWEEN PIERS OF IMPORT AND EXPORT IN THE STATE OF NEW JERSEY; FROM POINTS OUTSIDE NEW JERSEY DIRECTLY TO PIERS OF EXPORT WITHIN THIS STATE AND BEVERAGES FROM PIERS OF IMPORT WITHIN NEW JERSEY DIRECTLY TO POINTS OUTSIDE THIS STATE, (3) TRANSPORTATION OF RETURN SHIPMENTS OF ALCOHOLIC BEVERAGES ORIGINALLY WITHDRAWN FROM NEW JERSEY BY THE PERMITTEE.

THIS PERMIT IS EXPRESSLY CONDITIONED THAT EXCEPT FOR ALCOHOLIC BEVERAGES TRANSPORTED ON RETURN SHIPMENT, ONLY ALCOHOLIC BEVERAGES NOT INTENDED FOR DELIVERY, SALE OR USE IN THE STATE OF NEW JERSEY MAY BE TRANSPORTED UNDER THE TERMS AND PRIVILEGES OF THIS PERMIT.

THIS PERMIT IS EXPRESSLY CONDITIONED THAT ALCOHOLIC BEVERAGES SHALL BE TRANSPORTED IN VEHICLES OWNED OR POSSESSED BY THE PERMITTEE AND THAT EACH VEHICLE SHALL HAVE AFFIXED THERETO AN INSIGNIA ISSUED BY THIS DIVISION PURSUANT TO THIS PERMIT; AND ALSO CARRY A WAY BILL OR SIMILAR DOCUMENT FOR EACH SHIPMENT OF ALCOHOLIC BEVERAGES STATING THE NAMES AND ADDRESSES OF THE CONSIGNOR AND CONSIGNEE, THE NATURE AND QUANTITY OF THE ALCOHOLIC BEVERAGES BEING TRANSPORTED, THE PLACE AT WHICH SUCH ALCOHOLIC BEVERAGES WERE RECEIVED AND THE PLACE OF THEIR DESTINATION.


THIS PERMIT IS FURTHER CONDITIONED THAT RETURN SHIPMENTS SHALL BE MADE ONLY IN VEHICLES CARRYING A BILL OF LADING OR SIMILAR DOCUMENT FOR EACH RETURN SHIPMENT, STATING THE CIRCUMSTANCES SURROUNDING THE RETURN SHIPMENT, THE NAMES AND ADDRESSES OF THE CONSIGNOR AND CONSIGNEE, THE NATURE AND QUANTITY OF ALCOHOLIC BEVERAGES, THE DATE OF THE ORIGINAL WITHDRAWAL OF THE ALCOHOLIC BEVERAGES FROM NEW JERSEY, THE SOURCE OF ALCOHOLIC BEVERAGES AND THEIR DESTINATION.

PERMITTEE SHALL REPORT TO THE DIRECTOR, DIVISION OF TAXATION, DEPARTMENT OF TREASURY, BEVERAGE TAX BUREAU BY THE FIFTEENTH DAY OF EACH MONTH, ALL SHIPMENTS OF ALCOHOLIC BEVERAGES MADE DURING THE PRECEDING MONTH, STATING THE NAMES AND ADDRESSES OF THE CONSIGNOR AND CONSIGNEE, NATURE AND QUANTITY OF THE ALCOHOLIC BEVERAGES TRANSPORTED, PLACES AT WHICH BEVERAGES WERE RECEIVED/DELIVERED BY PERMITTEE, AND OTHER INFORMATION AS THE DIRECTOR SHALL FROM TIME TO TIME REQUIRE.

THE PERMITTEE HEREBY CONFERS UPON THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL AND HIS INVESTIGATORS, AUTHORITY TO INSPECT AND SEARCH, WITHOUT WARRANT, AT ANY TIME, ITS PREMISES AND VEHICLES.

THIS PERMIT SHALL REMAIN IN FORCE AND EFFECT UNTIL MIDNIGHT SEPTEMBER 30, 2008.

THIS PERMIT IS EXPRESSLY SUBJECT TO ALL LIMITATIONS AND CONDITIONS HEREIN SET FORTH OR HEREAFTER IMPOSED, AND TO ALL RULES AND REGULATIONS PROMULGATED HERETOFORE AND HEREAFTER BY THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL. THIS PERMIT MAY BE CANCELED BY THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL IN HIS SOUND DISCRETION AT ANY TIME WITHOUT NOTICE, REASON OR CAUSE.
